SECTION A.	Project Title: Understanding of Degradation of SiC/SiC Materials in Nuclear Systems and Development of Mitigation Strategies – University of California, Berkeley
SECTION B.	Project Description

The University of California, Berkeley, in collaboration with General Atomics, Oregon State University, North Carolina State University, and Los Alamos National Laboratory, proposes to develop a coating composition to prevent degradation of silicon carbide (SiC)-SiC materials in nuclear systems. Rapid throughput processing and testing techniques will be applied to conduct a thorough material analysis of the resulting SiC-SiC/coating structure and transfer the obtained knowledge to engineering scalable coating systems.

SECTION C. Environmental Aspects / Potential Sources of Impact

Chemical Use/Storage and Chemical Waste Disposal – Chemicals will be used, and all the necessary licenses and equipment and disposal plans will be in place.

SECTION D. Determine the Level of Environmental Review (or Documentation) and Reference(s): Identify the applicable categorical exclusion from 10 CFR 1021, Appendix B, give the appropriate justification, and the approval date.

References: B3.6 Siting, construction, modification, operation, and decommissioning of facilities for small-scale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial development.

B3.10 Siting, construction, modification, operation, and decommissioning of particle accelerators, including electron beam accelerators, with primary beam energy less than approximately 100 million electron volts (MeV) and average beam power less than approximately 250 kilowatts (kW), and associated beamlines, storage rings, colliders, and detectors, for research and medical purposes (such as proton therapy), and isotope production, within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible), or internal modification of any accelerator facility regardless of energy, that does not increase primary beam energy or current. In cases where the beam energy exceeds 100MeV, the average beam power must be less than 250 kW, so as not to exceed an average current of 2.5 milliamperes (mA).

Justification: The activity consists of university-scale research activities designed to develop a coating composition to prevent degradation of SiC-SiC in nuclear systems.
