SECTION B. Project Description

The Electric Power Research Institute (EPRI) proposes to develop an innovative qualification strategy for complex nuclear components produced by laser powder bed additive manufacturing which will be developed and demonstrated by leveraging relevant technology from recent welding developments, as well as, emerging process analytics, high-performance computation models, in-situ monitoring and big-data mining. Components will be made in typical laser powder bed machines.

SECTION C. Environmental Aspects / Potential Sources of Impact

EPRI has procedures in place to handle any waste that will be generated through this project. The action would not create additional environmental impacts above those already permitted.
