SECTION B. Project Description

Washington State University proposes to purchase and install a Teledyne Isco CombiFlash Rf+ Luman with UV-Vis and Evaporative Light Scattering Detector to improve the current purification abilities for newly designed and synthesized organic ligands.

SECTION C. Environmental Aspects / Potential Sources of Impact

Chemical Use/Storage – Work will be conducted in a chemistry laboratory using chemical reagents, acids, alkalis, and solvents.
