## SECTION B. Project Description

The University of Nevada – Reno (UNR) proposes to acquire a Hysitron PI-95 TEM PicoIndenter to allow *in-situ* characterization of irradiated materials under mechanical strain inside of a high-resolution transmission electron microscope (TEM). The Hysitron system will extend UNR capabilities for *in-situ* mechanical testing to nano-scale specimens. The new equipment will be incorporated into student courses and available for UNR faculty and external collaborator use.

## SECTION C. Environmental Aspects / Potential Sources of Impact

The university has procedures in place to handle any waste that will be generated through this project. The action would not create additional environmental impacts above those already occurring at the university.
