The University of Michigan proposes to acquire a MTI 32-station Automatic Arch Melting System (EQ-SP-MSM360) to enable rapialloy development efforts which can be quickly and efficiently screened in the Michigan Ion Beam Laboratory (MIBL). This will provide end-to-end high throughput nuclear materials discovery capability within the materials synthesis sub-laboratory of the Nuclear-Oriented materials and Examination (NOME) laboratory.

The university has procedures in place to handle any waste that will be generated through this project. The action would not create additional environmental impacts above those already occurring at the university.
