Oregon State University, in collaboration with NuScale Power LLC, proposes to design and construct a small modular reactor (SMR) simulator that is cloud-based and accessible to multiple research institutions. The simulator will be used in conjunction with a 1:3 scale height-scaled NuScale Integral System Testing (NIST) test facility for research related to SMR design and simulation of accident scenarios.

SECTION C. Environmental Aspects / Potential Sources of Impact

The action would not create additional environmental impacts above those already occurring at the university.
