SECTION A. Project Title: CITRC Double-wide Office Trailer


SECTION B. Project Description and Purpose:

N&HS requires additional field office space in the CITRC area for use by multiple programs. The trailer will supply valuable square footage for training activities. N&HS will lease and setup a double wide trailer between PBF-632 and PBF-638 pump house. The trailer will not be connected to water or sewer systems.

The specific tasks are identified below:

- 1. Lease a 24'x60' "nominal" double-wide field office trailer and transport it to CITRC. Trailer will need to be leveled, blocked, and anchored. Prefabricated stairs, handrails, and skirting will be installed.
- 2. Area around new trailer will need to be mowed. (Approx. 100' x 175').
- 3. Much of the area has been previously disturbed and will require some leveling of uneven ground. Ruts may need to be removed and depressions filled with gravel beneath the trailer to provide a flat surface.
- 4. Temporary power will need to be connected via an existing bang board using an S.O. cable (3W (L1, L2, N) + #6EG). Two (10') ground rods will need to be installed near the trailer and bonded to the panel.
- 5. Traffic cable protectors will need to be placed over the temporary S.O. cable.

Project activities have the potential to generate fugitive dust.

Emissions from machinery and equipment exhaust are expected.

Disturbing Cultural or Biological Resources

The proposed action has the potential to disturb biological and cultural resources.

Generating and Managing Waste

The installation of the trailer is expected to generate some industrial waste such as scrap wire, wood, plastic, etc.

Common office trash is expected. Waste paper will be recycled to the extent practicable. All solid waste will be managed by WGS.

Releasing Contaminants

Typical construction chemicals such as fuels, lubricants, adhesives, paints, concrete, concrete cure, asphalt, refrigerants, etc., will be used and will be submitted to chemical inventory lists with associated Safety Data Sheets (SDSs) for approval in the vendor data system prior to use. The facility Chemical Coordinator will enter these chemicals into the INL Chemical Management Database. All chemicals will be managed in accordance with laboratory procedures. When dispositioning surplus chemicals, project personnel must contact the facility Chemical Coordinator for disposition instructions.

Although not anticipated, there is a potential for spills when using chemicals or fueling equipment. In the event of a spill, notify facility PEL. If the PEL cannot be contacted, report the release to the Spill Notification Team (208-241-6400). Clean up the spill and turn over spill cleanup materials to WGS.

Using, Reusing, and Conserving Natural Resources

All applicable waste would be diverted from disposal in the landfill when possible. Project personnel would use every opportunity to recycle, reuse, and recover materials and divert waste from the landfill when possible.

SECTION D. Determine Recommended Level of Environmental Review, Identify Reference(s), and State Justification: Identify the applicable categorical exclusion from 10 Code of Federal Regulation (CFR) 1021, Appendix B, give the appropriate justification, and the approval date.

Justification: Activities are consistent with 10 CFR 1021, Appendix B to Subpart D, item B1.24 "Transfer, lease, disposition, or acquisition of interests in personal property (including, but not limited to, equipment and materials) or real property (including, but not limited to, permanent structures and land), provided that under reasonably foreseeable uses (1) there would be no potential for release of substances at a level, or in a form, that could pose a threat to public health or the environment and (2) the covered actions would not have the potential to cause a significant change in impacts from before the transfer, lease, disposition, or acquisition of interests;" and

B1.15 "Siting, construction or modification, and operation of support buildings and support structures (including, but not limited to, trailers and prefabricated and modular buildings) within or contiguous to an already developed area (where active utilities and currently used roads are readily accessible).
