SECTION A. Project Title: Advanced Test Reactor (ATR) Complex Temporary Office Facilities

SECTION B. Project Description and Purpose:

Revision 2:

The purpose of this revision is to capture a change from a single temporary modular office facility constructed from approximately 16 modular units, to two of these facilities if funding allows.

The remaining scope is still valid.

Revision 1:

The purpose of this revision is the project has changed from the installation of two temporary office trailers located east of TRA-1626 and TRA-1627 to a larger single temporary modular office facility constructed from approximately 16 modular units (i.e., trailers) to be installed south of TRA-1608. Utility connections will also include the ATR Complex firewater system. Limited amounts of asphalt and sidewalks may be removed and/or replaced for installation of utilities and to allow for safe access to the facility.

The remaining scope of the original EC discussed below remains valid.

The original scope of work is included below:

The number of employees at the Advanced Test Rector (ATR) Complex has increased and the facility needs additional office space. The proposed action leases and installs two temporary office trailers east of TRA-1627 and TRA-1626 as the need for additional space arises and until a permanent solution is identified (anticipated to be 3-5 years), then the trailers will be removed. The project grades and compacts the site and connects the facilities to electrical power, communications, fire alarm system, evacuation and voice paging system, potable water, and sewer. The action also removes the sidewalk to TRA-1626 to allow access to the water and sewer lines. Project scope includes replacing the sidewalk and adding walkways and stairs to the trailers.

SECTION C. Environmental Aspects or Potential Sources of Impact:

Air Emissions

The proposed action has the potential to generate fugitive dust.

Air emissions from portable electrical generators, in place less than one year, are not regulated.

Disturbing Cultural or Biological Resources

The trailer will be located on previously disturbed ground. Disturbance of biological and cultural resources is not anticipated.

Generating and Managing Waste

Industrial waste and common office trash will be managed by Waste Generator Services (WGS).

Office paper will be recycled to the extent practicable.

Releasing Contaminants

Typical construction chemicals such as fuels, lubricants, adhesives, etc., will be used while installing the trailers and will be submitted to chemical inventory lists with associated Safety Data Sheets (SDSs) for approval in the vendor data system prior to use. The Facility Chemical Coordinator will enter these chemicals into the INL Chemical Management Database. All chemicals will be managed in accordance with laboratory procedures.

Although not anticipated, there is a potential for spills when using chemicals or fueling equipment. In the event of a spill, notify facility PEL. If the PEL cannot be contacted, report the release to the Spill Notification Team (208-241-6400). Clean up the spill and turn over spill cleanup materials to WGS.

Using, Reusing, and Conserving Natural Resources

All materials would be reused and/or recycled where economically practicable. All applicable waste would be diverted from disposal in the landfill where conditions allow.
