SECTION A. Project Title: Installation of Exhaust an Orion XT Smoke Detector

## SECTION B. Project Description and Purpose:

The purpose of this activity is to install a 1" exhaust on the Orion XT smoke detector located in the first basement of Test Reactor Area (TRA)-670 next to the fire door between switch gear and primary pump corridors. The current configuration draws air from the motor corridor and exhausts the air in the switch gear room which causes smoke detector issues.

#### SECTION C. Environmental Aspects or Potential Sources of Impact:

## **Air Emissions**

Emissions typical of cutting/grinding/welding are expected. The emissions from this activity are not considered construction of a new stationary emission source.

#### **Disturbing Cultural or Biological Resources**

TRA-670 is eligible for nomination to the National Register of Historic Places and removal and/or changes of original features may adversely impact this historical property.

## **Generating and Managing Waste**

Polychlorinated Biphenyl (PCB) waste could be generated when performing activities associated with pre-1982 equipment and materials, including capacitors, lubricants and dielectric fluids, transformers and bushings, other electrical equipment/components, and painted surfaces.

## **Releasing Contaminants**

Typical construction chemicals such as fuels, lubricants, adhesives, paints, etc., will be used and will be submitted to chemical inventory lists with associated Safety Data Sheets (SDSs) for approval in the vendor data system prior to use. The Facility Chemical Coordinator will enter these chemicals into the INL Chemical Management Database. All chemicals will be managed in accordance with laboratory procedures.

Although not anticipated, there is a potential for spills when using chemicals or fueling equipment. In the event of a spill, notify facility PEL. If the PEL cannot be contacted, report the release to the Spill Notification Team (208-241-6400). Clean up the spill and turn over spill cleanup materials to WGS.

## Using, Reusing, and Conserving Natural Resources

Activities addressed by this EC have the potential for use, reuse and conservation of natural resources related to the following:

- Building energy use
- Generating landfill waste or construction and demolition wastes
- · Generating recyclable materials
