Project Title: Ontical Fiber A Pobble Red Broad and Burn Poactor Temporatures

The University of California, Berkeley proposes to assess the feasibility of designing a sodium-cooled breed-and-burn (B&B) fast reactor that will be able to establish and maintain a B&B mode of operation when fueled with depleted uranium. The proposed novel approach uses pebble-type fuel instead of fuel rods and fuel assemblies. Most of the work of this feasibility assessment will be based on computer simulation. However, limited experiments using facilities at the university for studying pebble dynamics and thermal-hydraulics characteristics in pebble-bed cores will be performed.

## SECTION C. Environmental Aspects / Potential Sources of Impact

The research would involve studying fundamental characteristics of pebble bed cores made of graphite pebbles. The action would not create additional environmental impacts above those already occurring at the university.
