SECTION B.	Project Description				

The objective of this project is to gather the existing analytical capabilities of the CLIM and integrate them into the UWNR to create the Center for Nuclear Fuels and Advance Reactor Materials Research. The proposed project has three key components:

- 1. Refinish the existing hot cell by refurbishing the existing manipulators, reconnecting the exhaust system and adding a shielded door.
- Install the infrastructure necessary for sample preparation and testing; including inert atmosphere glove boxes and fume hoods for sample preparation, test assembling, and sectioning and polishing of samples.
- 3. Relocate the existing CLIM facility within the UWNR and take advantage of an integrated radiation monitoring system.
